

Fact Sheet: Planned Parenthood's 2018-19 Annual Report¹

Planned Parenthood's Financials

- During fiscal year 2018-19, Planned Parenthood reported nearly <u>\$1.64 billion in income² and \$2 billion</u> in net assets³ -- similar to the previous year.
 - \circ Just over \$591 million came from private contributions, down 6% from the previous year.⁴
 - Taxpayer funding in the form of government grants, contracts, and Medicaid reimbursements hit a <u>record high of \$616.8 million, or almost \$1.7 million per day</u>⁵ an increase of \$53 million (9.4%) from the previous year to make up nearly <u>38% of Planned Parenthood's overall</u> <u>revenue</u>.⁶
 - Planned Parenthood's taxpayer funding has **increased by nearly 27% since 2010**.⁷
 - Last year Planned Parenthood reported <u>excess revenue of 244.8 million.</u>⁸ <u>This line item has</u> <u>been eliminated in the 2018-19 report; however, the excess of total revenue over total</u> <u>expenses is \$110.5 million⁹</u>

Abortions and Non-abortion Services: Change from Last Year and Long-term Trends

- Planned Parenthood performed 345,672 abortions¹⁰ in 2018-19 an increase of nearly 13,000 from the previous year and more than 3.3 million abortions (3,302,184)¹¹ over the past 10 reported years (2009-19).
- The number of patients (2.4 million)¹² remained constant from the previous report, while the number of abortions increased.
- In 2018-19, <u>abortions made up 95% of Planned Parenthood's pregnancy resolution services</u>, while prenatal services, miscarriage care, and adoption referrals accounted for only 2.7% (9,798), 0.6% (2,236) and 1.2% (4,279), respectively.¹³
- For every adoption referral in 2018-19, Planned Parenthood performed nearly 81 abortions.¹⁴ Over the past 10 reported years, the ratio was approximately 137 abortions for every adoption referral.¹⁵
- According to data from Planned Parenthood's own annual reports¹⁶, over the last 10 years:
 Total services are down 12.6%.

- With changing practice guidelines,¹⁷ total cancer screening and prevention services have dropped by 69%, including declines of more than 68% for breast exams and 72% for pap tests.
- Prenatal services are down nearly 76% from their peak in 2009.
- Contraceptive services are **down nearly 34%**.
- Unique patients have **dropped by 600,000 a 20% decline**.
- Approximately 240 (29%) of Planned Parenthood facilities have closed their doors.
